- Football will have coded entry instead of keyed entry
- Surveillance cameras both inside and outside football concession stand
- Suggested to add cooler alerts/alarms
- Still using same equipment (not getting any new equipment)
- If pop/chips are not expired we can donate to MTFD/MFD (pop/chips have a "consume by" date; while other items have a "best by" date)
- Jeff Johnson is working on a place to park/store our cart that is covered and lockable (he doesn't want any sheds)
- Writing up best practices information for new Concessions VP
- Biggest complaint in past has been consistency of concessions at all events (i.e. Tennis, Golf, Softball, Baseball, etc.), so Penni suggested opening concessions at more varsity events when multiple games/events on same day – need to coordinate with Aaron on schedules
